ORDER

The Cluster Facilitation Project has been formulated by the Ministry of Rural Development, Government of India to facilitate GIS based planning in backward regions/aspirational districts which has proved to accelerate development of such regions. Under the CFP, dedicated teams with new skills shall be positioned at Block, District and State levels who will work out multi-pronged strategy of leveraging the synergies of different flagship programmes of the Central/State Governments in convergence with MGNREGS through better coordination, planning and implementation. The guidelines issued for implementation of Cluster Facilitation Project under Mahatma Gandhi NREGS was communicated vide reference read as 1st paper above and it was requested that the State shall take necessary action for effective implementation of the CFP. Wayanad is the only aspirational district in Kerala and sanction has been accorded by the Central Government for implementing the scheme in any two blocks of the district.

2. The CFP is a 100% Centrally aided project and the expenses of which will be met by the Ministry of Rural Development. As per CFP guidelines, the proposal for CFP shall be submitted by State Mahatma Gandhi NREGA Cell to a Committee headed by Principal Secretary, Rural Development with members from the Finance Department, SRLM and Panchayat Raj Institutions. After approval by the Committee, the State shall send the fund requirements to Ministry of Rural Development along with the approved CFP proposal.

3. As per the reference read as 2nd paper above, the Mission Director, MGNREGS has submitted the CFP proposal with a request to constitute the Committee to examine the proposal as stipulated in the guidelines.

4. In the above circumstances, Government are pleased to constitute a Committee with the following composition to examine the project proposal furnished by the Mission Director, MGNREGS to implement the Cluster Facilitation Project in the State.
