**ORDER**

Government as per the order read as first paper above had issued sanction for construction of Anganwadis under MGNREGA in convergence with ICDS in line with guidelines issued by Government of India in this regard. Expenditure up to Rs.5 Lakh is permissible under MGNREGA and beyond this the expenditure shall be borne from the ICDS scheme of Government of India up to a maximum of Rs.2 Lakh. The Mission Director as per the letter read as 2<sup>nd</sup> paper above has requested to accord sanction to Grama/Block/District Panchayats to earmark provision to meet the excess cost if the construction cost exceeds Rs.7 Lakh.

Government have examined the matter in detail and are pleased to accord sanction to the Grama/Block/District Panchayats to earmark Plan/Other funds to meet the excess cost beyond Rs.7 Lakh for construction of Anganwadis under MGNREG Scheme based on the availability of fund of LSGIs after ensuring that there is no duplication of works since other plan schemes also exist for Anganwadi construction and also on condition that construction will be wholly executed following Mahatma Gandhi NREGA principles, stipulations and guidelines. Permission is also granted to open a bank account exclusively for receiving funds from GOI. All funds received from state Government shall be kept in a non interest bearing treasury savings account.
