ORDER

As per the Government order read as 1st paper above, an independent Social Audit Society was set up in the state under the name, Mahathma Gandhi NREGA Social Audit Society-Kerala, registered under Travancore Cochin Charitable Societies Act 1955. A Governing body of the Social Audit Society was constituted as per Government order read as 2nd paper above. The guidelines issued as per Government Order read as 1st paper above envisages to appoint a Social Development Specialist to work in partnership with Director and 3 Social Audit Experts to monitor and train the district resource persons. The committee constituted as per Government order read as 4th paper above, headed by the Chief Secretary, for selecting the resource persons to be appointed in the Social Audit Unit, interviewed the persons shortlisted by the Governing Body : Sri.Sreekumar.E, Addl. Development Commissioner (Rtd), CRD is ranked 1st in the select list of Social Development Specialist. The selection committee identified only one candidate ie Sri.George Jacob, Deputy Development Commissioner(Rtd), CRD , eligible for appointment as Social Audit expert.
