ORDER

The Director, Scheduled Tribes Development Department vide reference 1ST cited above has submitted a proposal for creating corpus fund for advance payment of wages under MGNREGS at an estimated cost of Rs.11,12,98,620/- (Rupees Eleven Crore Twelve Lakh Ninety eight thousand Six hundred and twenty only) to Government for consideration .

The Special Working Group which met on 27/03/2018 considered the proposal and recommended for approval.

Government accept the recommendation of the Special Working Group and are pleased to accord Administrative Sanction for the proposal for creating corpus fund for advance payment of wages under MGNREGS at an estimated cost of Rs.11,12,98,620/- (Rupees Eleven Crore Twelve Lakh Ninety eight thousand Six hundred and twenty only) subject to the following conditions.

1) The Director, Scheduled Tribes Development Department should put in place a proper monitoring mechanism to ensure the recovery of amount advanced to the Tribal families as advance wages through Kudumbasree once the wages are paid by Government of India to the workers' Bank Account .

2)The expenditure would be met from the provision available under the appropriate head of account.

3.)The fund release will be based on actual requirement and the fund released should not be parked in banks.
- 4) The expenditure in this regard will be met from the head of account 2225-02-102-85(P)during the year 2017-18.


